Abstract Deadline: March 31st, 2024

- Reactive and hot ground blasting
- Intelligent use of data & systems
- Technology and AI
- Decarbonisation

- Case studies are highly regarded and likely to be accepted



Abstract Submission Guidelines

Please submit your 200-300 word abstract and provide a concise summary of the paper:

- The reasons for writing/problem statement
- Methodology
- Results
- Brief discussion/implications

Paper Submission Guidelines

If your abstract is accepted, the process for your paper to be approved for presentation is described below.

Peer Review Process

Papers are considered by a committee of explosives industry professionals. This is not a blind review. The committee will determine the abstract/paper's relevance and substance based on the following criteria:

- Purpose and reason for the work
- Quality of the data collected
- Quality of the analysis and processes followed
- Degree of rigor behind the recommendations made or actions taken
- Conclusions based on data and analysis presented
- Application and interest to the industry

Special consideration for acceptance at the conference will be made for industry professionals, whose work is primarily day to day, hands-on-blasting in commercial construction, demolition, quarrying and mining applications.

Content must not be commercial:

- Papers and presentations should be educational and informative. They should not serve as an advertisement for a company and/or a product
- Company name may appear once only on the first page, after the author's name and paper title



- Describing a special type of product or service is fine, but a trade name may only be mentioned once
- We are seeking practical case studies, applications and the newest developments in our industry

Abstract Selection and Acceptance

Abstracts will be used only for tentative selection. Final selection and acceptance are based on the completed paper submitted on time.

Author Instructions

You will receive a paper template (Microsoft Word - .docx) to use for paper submission when you are notified of your abstract acceptance via email. That template **must be used** to submit your paper. Detailed instructions regarding paper format and presentation requirements will be provided after you receive the notification of abstract acceptance.

Paper Presentation

The Program Committee will assign each paper to a session upon acceptance of the completed paper.

Official Language

Papers must be submitted and presented in English, the official language of the conference.

Notification

Notification of acceptance or rejection of final papers will be sent by September 30, 2025.

NOTE: Multiple authors – Maximum of two speakers receive free entry to the conference.

March 31, 2025:	Last day for submission of abstract
April 30, 2025:	Notification of abstract acceptance
August 30, 2025:	Deadline for submission of draft paper/presentation
September 30, 2025:	Notification of final paper acceptance
October 31, 2025:	Final deadline for papers/presentations to be submitted
